COVID-19 Impact on School Closure

- Over 50 million children were kept at home in Nigeria.
- Over 1.7 million university students were also kept at home in Nigeria.
- Set back on students progress
- Institutions were making frantic effort to provide online learning infrastructures
- Capacity building of staff on the use of online learning tools intensified
- Online learning programmes on the Radio, TV and the use of Social Media
- Schools in the rural areas were not benefiting from the few initiatives
- Internally Displaced Persons and those in Correctional Centres were not catered for.

Quality Issues in Online Learning

- COVID-19 sent many institutions into panic mode.
- Haste to shift learning online without taking quality into account.
- Result poorly structured systems of coordinating learning activities.
- Compromised quality of academic project of institutions.
- Opens up criticism from sceptics higher education institutions have relegated students to the vagaries of technology.

Features of NOUN Exam On-Demand Platform

Types and Nature Misconducts Detected

- Several Impersonation cases (over 200 candidates out of over 40k attempts)
- Consulting external material via third party (Over 93 candidates out of over 40k attempts)
- Second party intrusion (over 180 candidates out of the total sittings)
- Blocking webcam after proctoring is successfully established to prevent human proctor monitoring student activities (over 250 candidates)
- Mobile phone Detection (Over 90 candidates)
- Several Looking away from the screen (over 400 candidates)

Challenges of Online Learning Assessment

- Poor internet connectivity
- Poor student awareness on virtual assessment ethics
- Cross device support
- Not all students afford PC or laptop
- Not all students have moderate computer skills
